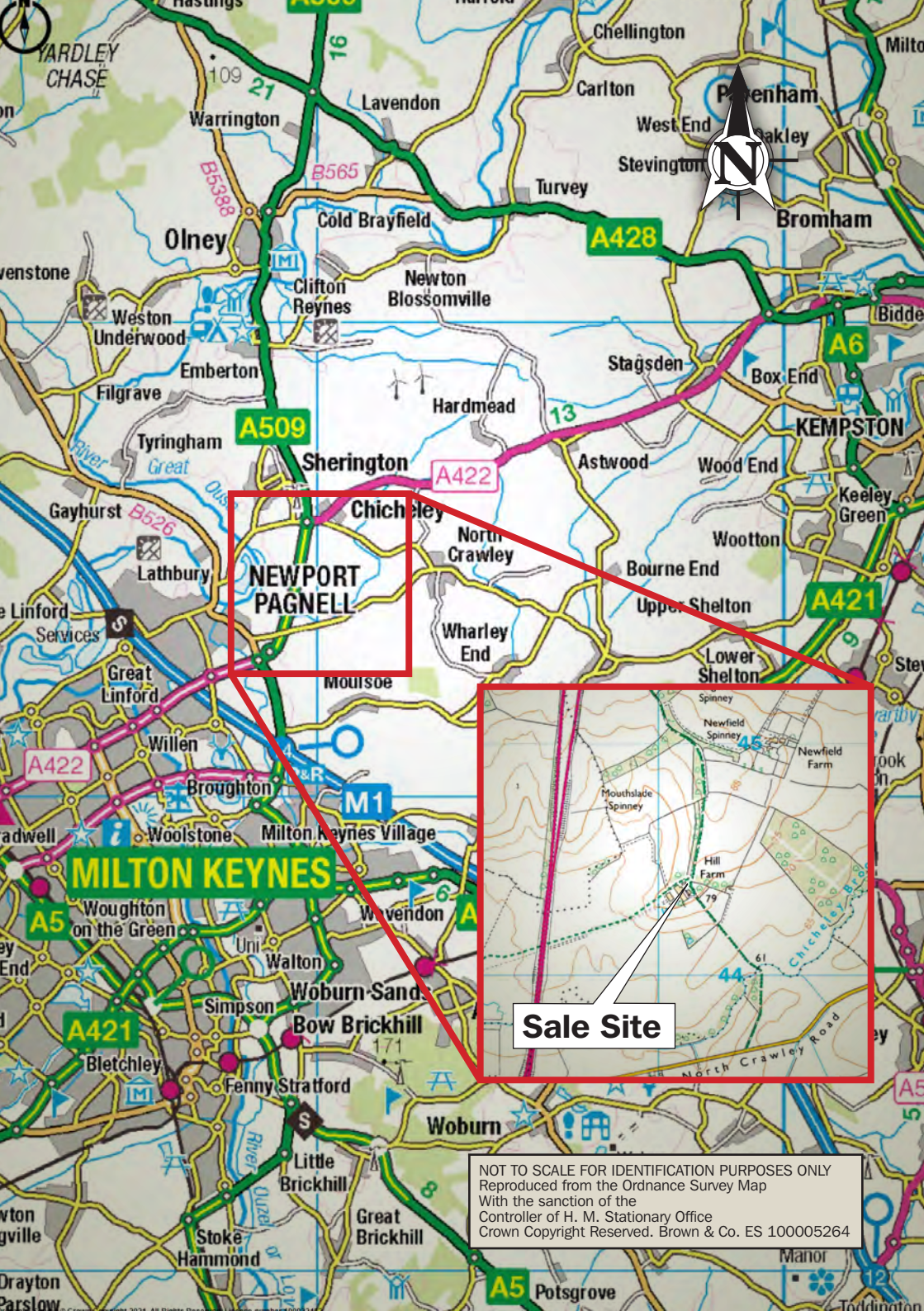

## PURCHASERS PLEASE NOTE:

**LOCATION** – From the M1 take the A509 towards Newport Pagnell. Follow the A509 London Road for approximately 1.3 miles, at the roundabout take the second exit onto B526 into Newport Pagnell. After 0.3 miles at the mini roundabout turn right onto North Crawley Road. At the next roundabout go straight on and follow North Crawley Road for approximately 1.1 miles, the farm entrance is on the left hand side.

From the North and East take the A509 towards Newport Pagnell. When going around the Newport Pagnell bypass follow signs for the B526. Take the third exit at the roundabout to the south of Newport Pagnell. After 0.3 miles at the mini roundabout turn right onto North Crawley Road. At the next roundabout go straight on and follow North Crawley Road for approximately 1.1 miles, the farm entrance is on the left hand side.

The sale ground will be signposted on the sale day. The nearest postcode is MK16 9HQ.

All persons attending the sale ground are reminded that there may be risks on the site including moving machinery and vehicles and to exercise caution at all times with any children being fully supervised at all times.
